#### **Project summary**

The project aims to increase inclusion of Ukrainian (UA) women to the labour market and society in countries of their temporary residence due to the War conditions by exploring opportunities for self-employment in cultural and creative sectors (CCS) with support of local CCS business. To achieve the aim, the project develops an educational-social Model "Successful UA women in CCS" with social innovative solutions to help UA women. The Model is based on a dual approach: 1) to increase women's motivation and competences for self-employment in CCS for integration into labour market 2) to implement social support mechanism by organizing UA Women's days, which goes beyond simply providing access to employment opportunities, but also encourages the commitment of local population and local businesses to ensure social integration of Ukrainian's women. The matching the UA women's developed in CCS business ideas with the local businesses in the field is one of the tasks of the Day and is a strong supporting mechanism for encouraging women to make the positive changes in their today unsecure lives.

#### Objectives are:

- to motivate UA women for self-employment in CCS
- to enhance UA women competences and skills for self-employment in CCS
- to implement UA Women's Day as a social support mechanism for women's social inclusion to labour market and society to ensure the facilitation of the Model

To achieve objectives, the educational-social Model "Successful UA women in CCS" is developed with 4 modules:

- 1. Motivation workshop "Innovation solutions in CCS for Ukrainian Women"
- 2. e-Studio "Women's self-employment in CCS-how to be successful"
- 3. "Ukrainian Women's Day" social support mechanism for integration to labour market and society
- 4. E-Toolkit for facilitators of the Model

### **Project summary**

The VMU Ukrainian Centre, established on 11 June 2022, is an open space for people who have fled Ukraine that provides various services and responds to their cultural, linguistic, educational, and psychosocial needs. A broader aim of the project is to explore and define the social innovation implementation model of the Ukrainian Centre in Lithuania, which is based on developing skills, building solidarity and fostering community cohesion. Through a multifaceted approach to social inclusion encompassing education and active participation (language teaching, leadership training, youth think tanks, Saturday schools, consolidated events, international conferences and forums), the project seeks to empower Ukrainians through knowledge sharing and collaboration, advocacy and policy influence and exchange best practices across Lithuania and with the partners in Poland.

Hence, the concrete objectives of the project are as follow:

- 1) to pilot centrally located services in other regions of Lithuania and develop regional community leader network by training Ukrainian community leaders;
- 2) to create a seed funding scheme that would enable Ukrainian leaders to initiate local actions that help to meet the needs of displaced Ukrainians regionally;
- 3) to expand the activities of youth think-tanks as a participatory process that engages young Ukrainians and creates a platform to meet various decision makers and discuss relevant topics;
- 4) to organize activities of Saturday/weekend schools and summer camps that engage Ukrainian children, to enable participation of their parents in community activities, language learning, increase their attractiveness for the labour market;
- 5) to create language learning opportunities, educate displaced Ukrainians about national law and policies in relation to employment, education, family, etc.;
- 6) to create a cross-sectoral cooperation network of organizations and institutions actively working on advancing the lives of displaced Ukrainians in EU.

### **Project summary**

As the conflict between Russia and Ukraine persists, emergency responses must evolve into sustainable solutions to foster integration and social inclusion of Ukrainians in European societies. This project aims to address this need by scaling and transferring the YMCA's successful community-based "eDU Hubs and Mobile Centres" model.

The model leverages long-standing community centres to provide holistic services, including education, skill development, childcare, mental health support, language acquisition, and employment assistance. The hubs serve urban areas, while mobile centres reach rural communities, ensuring accessibility for all refugees.

Building on the past two years of best practices, the project will enhance organisational capacities, promote intercultural integration, and engage more stakeholders from public, private, academic, and civic sectors. This aligns with the call's objective of integrating and socially including Ukrainian refugees by focusing on employment, essential services, support mechanisms, and community building.

The project will utilise a social innovation scaling methodology to achieve its objectives, including:

- · High-quality management and coordination.
- Co-creation and mutual learning among partners and practitioners.
- Development of innovative upskilling and integration approaches.
- Facilitating stakeholder interactions for joint solutions.
- Training and mentoring on the model's implementation.
- Dissemination of findings and advocacy for systemic change.

The project's key activities will include needs assessments, stakeholder mapping, piloting innovative solutions, and sharing knowledge through transnational cooperation. Expected short-term results include improved access to support services for 6,000 Ukrainian refugees, with transformational impact on at least 1,500 individuals. Long-term, the project aims for sustainable social integration and a scalable model adaptable to other contexts, fostering a more inclusive Europe.

### **Project summary**

SWEETIE replicates an intervention model tested in Italy (SWEET) by transferring it to Greece and Poland and by scaling it up in Italy at a political level. SWEETIE aims to facilitate the social inclusion of refugees fleeing Ukraine, particularly women and youth, who are the majority of Ukrainian refugees, and to improve the efficiency and effectiveness of public services. It achieves these objectives by influencing specific areas of the welfare and labour systems (i.e., job access and inclusion, education, healthcare) in each country for these to become gender-responsive and culture-sensitive public services. The intervention acknowledges 3 actors as key ones to achieve this transformation: public service staff and professionals, members of the Russophone diaspora, Ukrainian service beneficiaries. The Russophone diaspora is a key connecting point between public service providers (which bear the duty of respecting rights) and the Ukrainian beneficiaries (which hold the rights), being the diaspora a main channel of the migratory pathway for women fleeing the conflict. Through SWEETIE, each actor's capacity is strengthened in terms of knowledge, skills, networks, awareness, power. The project goal goes beyond reinforcement of each stakeholder: coordination and cooperation among them are fostered through participatory workshops to co-develop improvements in terms of services (in Greece and Poland) and of policies (in Italy) with the final aim of creating inclusive, culture- and gender-sensitive welfare and labour systems.

A specific WP has been foreseen to ensure that learnings from the project are shared among diverse stakeholders at national and European level to put the basis for further replication in new geographical areas, rights, and areas of the welfare systems.

### **Project summary**

Project Volunteers Everywhere aims at the integration and social inclusion of refugees fleeing Ukraine by connecting the refugees with Czech, Polish, and Lithuanian volunteers from their neighborhoods.

The partners want to re-vitalize the massive support for Ukrainian refugees from the first months of the Russian aggression and build a trained network of volunteers willing to further assist the refugees in inclusion into the local community.

This project allows for the sharing of best practices and analysis of the problem among diverse stakeholders (3 round tables, meetings with stakeholders, and workshops on migration and refugee topics) and enables each partner to contribute their expertise to the project's goals. This kind of collaboration can lead to more effective volunteer management strategies and greater impact both locally and globally. There will be organized also 4 other mutual learning events (3 on-site, 1 online) to exchange knowledge and experience with other beneficiaries.

The volunteer assistance has been concentrated in large cities, however, the refugees have moved from the cities into the regions to seek jobs and accommodation. Introducing a mobile application tailored for connecting refugees and volunteers in remote areas can be an innovative approach that complements institutional measures and together with the professional support of the project partners fosters a sense of community and solidarity. Minimum of 400 volunteers will be recruited, trained, supervised, and supported by the project partners from Lithuania, Poland, and Czechia; minimum of 400 refugees will register as users in the mobile application.

The sustainability of the project will be ensured by the project partners who will keep promoting the Mobile App in their public events and will keep supporting the target groups after the EU support ends. To ensure independent monitoring and evaluation an expert services from an academic partner will be purchased (university or applied research institution).

### **Project summary**

Integrated Smart Inclusion by volunteers (ISI) aims at facilitating active and participatory integration for Ukrainian refugees. Training volunteers to become local integration coaches, will offer flexible and adjustable integration support to Ukrainian refugees, adapted to their needs. Through the local coaching and activity offer, which will be implemented by the trained volunteers, meeting spaces for Ukrainians and the local population are created to foster a two-directional integration.

The training module to be developed throughout the course of the project will include one part jointly conceptualised by the project partners, including themes such as communication, psycho-social care and intercultural skills. This part will be complemented by a locally developed "knowledge hub", mapping locally available support offers from language courses, to employment support and cultural offers.

Having completed the training, volunteers are equipped to empower Ukrainian refugees in the areas where they need support, as well as competent in the many facets required for successful integration and social inclusion, including the facilitation of encounters between the local population and Ukrainians.

### **Project summary**

The "FAMILY (Fostering Adaptive and Resilient Migrant Families) – Building Resilience in the Face of War and Forced Migration" project aims to develop and test a model for building resilience among families of forced migrants. The project will focus on helping participants cope with war trauma and the challenges of migration through collaboration with local communities. By leveraging best practices from Poland and Germany, the project will provide support for 195 participants, including 75 adults (40 families, some of which are single parents) and 120 children from these families.

The project will achieve its objectives by implementing a multi-phase approach that includes planning, community engagement, model development, and pilot testing. Local communities will be actively involved in the process to ensure the model is culturally sensitive and effective. The project will use data collection and analysis to monitor progress and make necessary adjustments.

Expected outcomes include improved resilience and coping mechanisms for migrant families, strengthened community support systems, and a scalable model that can be replicated in other regions. The project aligns with the Call's objectives by addressing the urgent needs of migrant families, fostering community collaboration, and promoting the integration and well-being of migrants in host communities.

### **Project summary**

The IMMERSED project is based on innovative citizen-centered solutions that will provide employment sustainability and financial resilience to Ukrainian refugees. This will be achieved through a multi-layered model of well-being support and immersion in local communities.

The IMMERSED project will help address the specific social problem of lack of employment sustainability support for Ukrainian refugees in host countries, which also generates inability to achieve financial resilience, low well-being and difficulty integrating into local communities. The IMMERSED project will leverage good practices from existing products and adapt them to the new situation of Ukrainian refugees. The IMMERSED project will empower citizens and improve the way our societies and their social welfare systems function and provide support to Ukrainian refugees.

The main pillar of the IMMERSED ecosystem will be a strong network and collaboration among partners, but especially with associated partners who represent the quadruple helix model of the four main actors in the innovation process – public, private, academic and civil society.

By assessing existing evidence, the IMMERSED project will build the foundation for a new approach to supporting employment sustainability and financial resilience for Ukrainian refugees through:

- Training and creating materials for employment sustainability trainers.
- Creating a new model of discussion clubs,
- Mapping local initiatives (barter and networking opportunities with reference to Quadruple Helix, bottom-up initiatives and local communities),
- Comprehensive (addressing different anxieties and traumas) mental health support program for Ukrainian Refugees.

These solutions will be tested in local communities in Poland (Warsaw and Katowice), Slovakia (Žilina and Presov), and Romania (Cluj-Napoca and Iasi) with the support of the associated partners mentioned in the proposal, but also with the participation of a wide range of stakeholders.

#### **Project summary**

According to the UNHCR, 22% of Ukrainian refugee households include members with disabilities who face greater challenges accessing rights and healthcare. As displacement continues, their vulnerability may increase, affecting decisions to return due to difficulties in securing long-term housing. Additionally, 13% of households with vulnerable members need alternative accommodation after free programs end, yet struggle to find work and suitable housing. OECD research highlights the challenge of providing adequate, affordable housing for people with disabilities and stresses the importance of innovative solutions. The EU.RESP.4UA focuses on UA refugees who fled in Italy (Milan), Lithuania (Vilnius/Kaunas) and Romania (lasi) looking for long-term housing solutions or hosted in health centres, isolated from the rest of the community. The project aims to contribute to the integration and social inclusion of refugees fleeing Ukraine, specifically those with special needs, by exploiting an innovative approach and housing solution – actually implemented in Italy – and by igniting an innovative, multilayered and multi-stakeholders set of supporting actions culminating in a re-inforced, integrated model specifically tailored to vulnerable refugees (physical/mental disabilities, orphans backgrounds, PTDs): stemming from a housing-first approach the project will design and deliver strategic (policy) and tactical actions for the creation of an inclusive and fertile environment for skills development to an autonomous life, facilitating the job-related skills improvement and better access to social services. The project will design and deploy a community-based social experimentation project, building on new – or re-inforced – forms of collaboration between policymakers at different levels (European, regional and local) civil society organisations, social cooperatives, foundations, social housing providers, citizens, refugees communities and the private sector.

### **Project summary**

The project represents the setting up of a comprehensive support system for Ukrainian children in the education system of the Czech and Slovak Republic. It outlines a complementary link between NGOs and public institutions, schools, and the counselling system. Comprehensive support includes 3 pillars identified by national analytical reports: psychosocial, language and career support for children in schools and methodological guidance for educational and other staff in schools. The activities within the WP002 are continuously building up on each other: specific field work with Ukrainian children and parents focused on language, psychosocial and career areas, training of experts and job shadowing abroad, revision of existing materials and development of missing methodologies and textbooks (missing in both countries). This is followed by a new postgraduate training programme for teachers and professionals in schools. The project outlines comprehensive support system in the school environment, implements changes in the content of undergraduate curricula of faculties of education at universities for future educators. By analyzing the current situation at the very first stage (existing solutions and support) and proposing further recommendations to fill the gaps, activities A003.001 to A003.003 create a prerequisite for sustainability and a system of support for these children. This will be followed by advocacy, proposals for legislative changes and awareness raising. The consortium partners are complementary as government and non-profit sectors, have a wide network of partnerships with government and NGOs. The partnership between the Czech Republic and Slovakia represents a support to Central and Eastern Europe, where there is still relatively little experience with such a wave of refugees, insufficient systemic solutions, but intense demand from schools and regions.

#### **Project summary**

The project aims to enhance the social and labour market inclusion of displaced people from Ukraine (DPU) in Poland and Italy by refining and expanding innovative approaches from current interventions. It addresses the mismatch between DPU's qualifications and job opportunities, and promotes best practice exchanges among consortium members.

Spanning 18 months, the project is divided into two phases. Phase 1 centres on activities in Poland's Kuyavian-Pomeranian Voivodeship and Italy's Piedmont region. Key initiatives include provision of access to social services in Italy through the RED Nova's Helpline, and in Poland, job counselling and language courses via a one-stop shop (OSS) by Emic. PAH, Emic, and RED Nova will re-assess stakeholders from public and private sectors, strengthen existing connections, expand to new ones, and prepare an engagement plan for Phase 2. Phase 1 lays the groundwork for research by Opora, analysing policy frameworks and DPU's needs. The goal of the research is to identify best practices, areas for improvement, and scaling opportunities. The phase concludes with mutual learning sessions to enhance ongoing interventions.

Phase 2 aims to scale up interventions in both countries. RED Nova will enhance its Helpline with job counselling to better match DPU with job opportunities. In Poland, PAH and Emic will collaborate to advance the OSS through peer learning with RED Nova, introducing vocational training and an entrepreneurship academy. Support for selected vulnerable households, including housing assistance, will also be provided. Both partners will implement stakeholder engagement strategy with the aim of sensitising potential employers to DPU's needs.

Targeting 2690 DPU, the project seeks to improve their employability and societal integration. Additionally, it aims to develop and disseminate a Best Practice Toolbox based on the research and activities, benefitting civil society organisations and public and private stakeholders.

### **Project summary**

The project U-PLAYS supports Ukrainian youth integration through sports, employment training, and language learning. Aligned with the ESF+ initiative's goals, it mitigates the societal impacts of Russia's war against Ukraine by fostering social inclusion. The project aims for sustainable impact, creating a scalable model transferable to other EU contexts. A comprehensive dissemination plan will share methodologies and successes through various networks, promoting best practices in social innovation and refugee integration. Thus, U-PLAYS addresses immediate needs while fostering long-term social inclusion and empowerment of Ukrainian youth, aligning with the call's objectives. This initiative is born from a successful implementation of the project in the local context in Latvia and will now see its first scalability to a European context. By building on proven methodologies and outcomes, U-PLAYS aims to extend its impact beyond national borders, enhancing the integration of Ukrainian youth on a broader scale.

#### **Project summary**

The EU4UA project aims to mitigate the societal consequences of Russia's aggression against Ukraine by fostering the social and labour market integration of Ukrainian refugees in Poland, Romania and, broadly, across EU countries.

The main project objective, addressing this ambition, is to "deploy the potential of social innovation approach to develop, pilot, and disseminate an innovative, comprehensive, evidence-based blueprint (1 pc.) within 18 months, that supports the efficient social and labour market integration of Ukrainian refugees in Poland, Romania and across the EU, leveraging collaborative and joint efforts of partners and previous EU initiatives among diverse stakeholders, ensuring sustainable impact, and fostering policy integration through continuous evaluation and feedback mechanisms".

The blueprint, as a new response to clear social needs and key project results, determines beneficial, direct and long-term project impact on civil society and its capacity to act for the smooth social transition of UA refugees into host communities and labour markets.

The objective addresses the newly emerged social demand which needs a citizen-centred solution. It will be achieved by:

- a) developing new, evidence-based and carefully mapped, policy approach (WP2 goal) summed up in a research report (D2.3)
- b) the report is a prerequisite to designing a multi-stakeholder-driven blueprint (WP3 goal): a bundle of need-tailored, context-specific public services and commodities (D3.3)
- c) the blueprint will be piloted among the end-users (WP4 goal), fine-tuned iteratively (PDCA approach), and finally evaluated (D4.2)
- d disseminated (WP5 goal) among wide European, national and local stakeholders (D5.4) as an open, adaptable and replicable solution, complementing existing measures.

Such an approach addresses the call by fostering EU social cohesion and enhancing civic and public policy resilience to support Ukrainian refugees amid prolonged conflict escalation.

#### **Project summary**

In the context of integration, social inclusion and prevention from going missing of displaced youth from Ukraine, this project addresses their specific challenges by empowering them to make informed decisions and seek support, especially when they become unaccompanied or transition into adulthood. The complexities of their already vulnerable situation are further exacerbated by persistent risks of malicious offers leading to exploitation, trafficking, and scams, which are of particular concern. Despite the availability of information and services targeted at Ukrainian refugees in EU Member States, the nuanced support needed for this specific group has been overlooked.

This project presents a scalable, and sustainable innovative solution to fill this critical gap. The countries implementing solutions are Poland, Hungary and Czech Republic, focusing on the capital cities. By leveraging technology in the form of a mobile application, Miniila, and participatory project design, this initiative aims to create a sustainable impact on the integration and protection of displaced Ukrainian youth.

The mobile application will offer a platform for these youths to find reliable information and resources, ensuring they are aware of their rights and available services. The participatory design ensures that their voices are heard and integrated into the project's development, making it more effective and relevant to their needs.

Moreover, this initiative aims to influence regional, national, and European policies by highlighting the specific needs and vulnerabilities of displaced Ukrainian youth. Through collaboration and coordination with local integration actors, the project seeks to address the identified gaps and advocate for more comprehensive support systems and policies.

Ultimately, this project aims to create a long-term, positive impact on the lives of displaced Ukrainian youth, fostering their integration and social inclusion while ensuring their protection and well-being.

### **Project summary**

This project leverages Ireland's network of host communities and Ukrainian Beneficiaries of Temporary Protection (BOTPs) to create a scalable, technology-driven model for refugee integration.

"Community Connect" has two elements: community engagement and technology-supported solutions. Both elements will be developed, monitored and evaluated by academic partners using qualitative and quantitative research, so real participation of community members and BOTPs is ensured and progress and outcomes are measured by clear integration and human rights indicators. Sustainability and scaling will be enhanced by the presence of partners in two EU member states.

Helping Irish Hosts (HIH), has spent two years successfully matching 2,550 Ukrainian BOTPs with 1,140 Irish hosts using its best in class matching model and person-centred approach. They consider individual needs from all perspectives – host and guest – to ensure empathetic integration and matches that sustain for 12 months or more.

We will enhance our matching process by incorporating new data-driven inputs to focus on integration and making the process more scalable. With University College Dublin (UCD) and Pairity, the HIH personal approach will be supplemented by the iterative development of a secure, digital matching platform that allows us to scale and adapt for local authorities across Ireland and the EU, enhancing capacity for local integration teams. This technology allows us to create personalised matches while expanding our capacity to meet growing demand.

The project involves host communities at every step. Community Coordinators and expert facilitators will empower BOTPs to find pathways within their new communities. Our community-first approach actively seeks input from local residents to identify their needs, such as childcare, transportation, and social engagement, and integrates these insights into the matching process.

#### **Project summary**

SMART UA will boost the integration of Ukrainian refugees in Hungary, Romania and Slovakia through a multi-stakeholder cooperation. The project is coordinated by JRS Europe (Belgium) in a consortium with 11 beneficiaries and partners, including local authorities, social institutions, research institutes, housing and job placement centers in 3 EU countries bordering war-affected Ukraine.

Key elements of the innovative social inclusion approach include: enhancing the EU skills recognition profile tool; in depth analysis reports of the existing gaps and emerging innovative schemes in the housing and labor market in Hungary, Romania and Slovakia; capacity building on base of the research findings with 3 wider networks of 90-150 actors on local level; setup of local and interconnected multi-stakeholder cooperation's in the 3 EU MS to promote innovative schemes for housing and employment; a transnational exchange and share scalable practices through an European event and online 100.000 users through awareness raising.

SMART UA aims to support UA refugees in their pathway to a successful social inclusion, as they face multiple discrimination, particularly women with children, elderly, with disabilities, who make up 95% of the target group. The project tackles the main obstacles to UA refugees' integration: access to decent housing and matching with labor market opportunities. Further, housing and job placement centers, human resources departments in enterprises and local authorities are facing multiple challenges in their integration efforts, due to a drain of resources and isolation of initiatives. SMART UA will respond to these challenges through newly created local multi-stakeholder networks and in 3 pilot projects enhance the living conditions of 1,750 UA refugees in Romania, Hungary, and Slovakia, by improving their employability and access to housing. The exemplary action will document innovative insights and produce sharable tools for replication and adaptation.

### **Project summary**

Many Ukrainian refugees across Europe are currently facing diverse mental health challenges. According to a recent survey of those living in Gothenburg, Sweden, 50% reported feeling lonely, while 70% reported experiencing symptoms of depression and/or anxiety. Many have also noted that their poor mental wellbeing is limiting their ability to fully embrace their present lives and integrate into Swedish society. However, due to a range of factors, very few Ukrainian refugees succeed in accessing relevant support through the public healthcare system.

This project therefore aims to directly address this identified issue and increase access to high-quality, grassroots-based mental health support for Ukrainian refugees. This support should be tailored to their unique needs, have low thresholds of access, and be designed to complement more formal alternatives already provided elsewhere.

This project brings together three partner organisations from across Sweden and Finland, each with their own unique expertise linked to the project's theme. Together, they will test the replication of an innovative peer-led model originally developed to support increased mental wellbeing of migrant communities in Finland. Through a series of mappings and transnational exchanges, the model will be adapted to serve the needs of Ukrainian refugees currently living in Sweden. There will be a strong emphasis on bottom-up approaches, active participation of the target group, and a 'build-measure-learn' agility to adapt practices in line with feedback.

Following the completion of a pilot, partners will disseminate their results and learnings in order to contribute to growing evidence on the links between refugee mental health and integration, as well as the role of social innovation in these processes. They will furthermore have convened a learning circle of like-minded peer organisations from Sweden and Finland, to build community and enable more long-term transnational exchange.

### **Project summary**

The HEART project is essentially a transnational social research project with the aim of finding effective ways to provide support to Ukrainian refugee women in finding their own ways towards an independent life in the host countries.

Through the implementation of two NGOs (Hungrian Interchurch Aid in Hungary and AIDRom in Romania), both with substantial experience in supporting Ukrainian refugee people, empowerment is declared to be in the centre of the concept, through exploring, testing and piloting innovative methods in 4 thematic areas: providing GBV related support prevention and response); access to services and social inclusion; housing solutions; employment options.

After piloting the innovative methods through a profound experience and knowledge exchange, liaising with multiple stakeholders, involving volunteers and the beneficiaries in all stages, 4 Theory of Exchange / Standards of procedures will be compiled for further use by the two organizations in the continuation of the same activities, as well as for later use by a wider (national and EU) level communities.

The approaches experimented then in the field of income generation through assisting different forms of self-initiatives will be compared and published in a Comparative Study for use for multiple purposes. This is then followed by the development of an Incubator programme where the models tested will be analyised and the most effective one selected for actual implementation in the Centre of Support for Ukrainian refugees opened and maintained by HIA in Budapest.

The project is expected to offer useful outcomes and impacts on several levels of addressing the challenges Ukrainian refugee women face in terms of social inclusion and finding their own ways in and with the host community.

#### **Project summary**

The project contributes to the integration and social inclusion of Ukrainian (UA) refugees in Germany, Poland, and Lithuania, focusing on caregivers of persons with disabilities (PWD), and partly on PWD.

PWD caregivers among UA refugees are in an even more stressful situation. Their integration (esp. into the labour market) is impeded by their caring tasks, additional psychological strain and often social isolation. So far, their specific needs could often not be met sufficiently, not least because there even are not enough reliable data for a systematic outreach to them.

The consortium consists of the applicant Austausch e.V. (Berlin) and the co-applicants Mudita (Cracow) and Lithuanian Disability Forum (Vilnius). Together they bring to the project longtime expertise and networks in the field of inclusion for PWD. All three have since 2022 expanded their commitment to PWD and their families among UA refugees. They have jointly designed the project, aiming at an innovative model that complements existing services for UA refugees with tailored activities for the target group.

The project activities and objectives comprise: expert research and analysis and dissemination of the results to stakeholders as a basis for well-informed initiatives and decisions (DE, PL, LT); empowering the target group to master integration through information, networking (incl. with local PWD initiatives), self-help groups, trainings, and mentoring (DE, PL); supporting integration into the labour market by facilitating internships and/or suitable employment (DE, PL); raising awareness among decision-makers, employers and the general public regarding the target group, through advocacy and information campaigns (DE, PL, LT); networking between all relevant stakeholders (DE, PL, LT). Detailed monitoring and evaluation will help to secure the model's long-term impact through capacity-building, new networks and transferability to other regions and countries.

#### **Project summary**

Self-employed Ukrainian refugees in Poland and Germany encounter various challenges such as limited business experience, management skills, access to capital, lack of supportive ecosystem, psychosocial distress, etc. Business Development Service Providers (BDS), who should support them to overcome these challenges, often lack understanding of their needs and expertise to tailor their services.

Project OPPORTUNITY is an 18-month initiative aiming to develop sustainable solutions by adapting and applying the SIM – Opportunity Self-Employment model to Poland and Germany. This will enhance support for Ukrainian refugees and improve connections with BDS stakeholders, thus fostering social change where institutional frameworks are lacking.

By bridging the gap between refugees and BDS providers, the project focuses on enhancing the support system and fostering social cohesion. This directly contributes to the call's key objective of integrating and socially including refugees from Ukraine.

The project's Theory of Change posits that adapting the proposed SIM to the needs of self-employed Ukrainians, upskilling BDS Providers to offer tailored support, directly improving refugees' skills, and increasing awareness among key stakeholders will lead to sustainable growth among self-employed Ukrainians.

Through extensive research, curriculum development and capacity-building, the project consortium will tailor the Opportunity Self-Employment model to Ukrainian refugees needs. Enhanced inclusion of relevant stakeholders in the project, as well as strategic communication and advocacy efforts, will strive for a sustainable impact, that will not only benefit Ukrainian refugees but enabling temporally sensitive and contextually relevant solutions for refugees from different backgrounds to engage on the self-employment journey.

IRC Poland will lead the project in partnership with Microfinance Center (Poland), IRC Germany and Perspektive neuStart, European Humanities University (Lithuania).

### **Project summary**

SIP establishes comprehensive socio-economic integration and psychosocial support pathways for vulnerable Ukrainian refugees in Italy and Poland. The vision is to create lasting improvements in their socio-economic status and mental well-being, setting a precedent for future initiatives. SIP leverages the consortium's combined expertise, which have a history of successful socio-economic integration and psychosocial support interventions.

### **Project summary**

RIF4UA – "Scaling-up Integrated Services within Resilience and Innovation Facilities for Ukrainian Refugees Inclusion" will provide comprehensive integrated services of social support, skills development and education, facilitation of access on the job market and participation for the Ukrainian refugees that fled the war to Romania and Hungary to support their integration and social inclusion. Moreover, it will build on the involvement and cooperation between various local stakeholders to complement each other and increase the capacity of intervention at local level for refugee support. The project will start with a needs analysis among the refugee community and a mapping of the local stakeholders to uncover the existing gaps in the provision of support for refugees in Brasov and Budapest. These gaps will be addressed within the Resilience and Innovation Facilities (RIFs) already developed by Tdh in both cities. Initially established as centres for digital skills building for children and youth, they will be scaled-up as single-entry points for Ukrainian Refugees to access the above-mentioned types of services, responding to the needs of entire families. Multidisciplinary teams will facilitate access to basic needs and specialised services via information, referral and protection assistance. They will also offer skills development opportunities to improve the employment opportunities. To facilitate access to employment opportunities for children to allow their caregivers time to pursue employment opportunities. To facilitate access to employment opportunities, refugees will be supported in improving their skills related to job search, matching them with existing vacancies and having their qualifications recognized in the host country. Furthermore, the project will address social cohesion in the local host communities through a communication campaign developed in a participatory manner with materials that would give a voice to both Romanian/Hungarian and refugee youth.

### **Project summary**

SIMPLE Project (Social Innovation for Migrant Integration and Employability) aims to:

- 1) Identify and scale up best practices in social innovation to enhance the employability and integration of Ukrainian refugees, focusing on educational interventions and vocational training.
- 2) Empower vulnerable groups, particularly women and older adults, by providing targeted support to enhance their skills and employability.

- Mapping, engaging, and empowering stakeholders from various sectors to support and implement the new social innovation approach for Ukrainian refugees.
- Implementing and testing the developed model of social innovation for Ukrainian refugees in real-world settings to validate its effectiveness and adaptability.
- Promoting project outcomes, enhancing stakeholder capacities, and ensuring sustainable impact through comprehensive dissemination and stakeholder empowerment activities.

#### **Project summary**

The WISE – Supporting Ukrainian (UA) Refugee Women's Socio-Economic Integration and Wellbeing project proposes a social innovation model which integrates mental health and psychosocial support (MHPSS) with employment services enabled by technology driven solutions to create a holistic support system.

WISE aims to improve the socio-economic inclusion and wellbeing of employable refugee women from UA in Italy (IT) and Bulgaria (BG), by piloting and scaling-up Holistic Support Centres (HSCs) with a trauma-informed and gender-sensitive approach that build on the Women and Girls Safe Space (WGSS) methodology and complement it with employment and social support services. The project will enhance UA women's employability, skills-job match, lifelong learning and access to the labour market, enable them to better navigate and access social and public services, and enhance their mental and psychosocial well-being. The project pays particular attention to women affected by the waiting dilemma, helping them overcome their concerns and seizing opportunities for professional growth that may be relevant to UA when and if they decide to go back.

WISE uses an iterative process to interlock and scale-up a social innovation to transform the refugee situation into opportunity, for the individual, host countries, and UA. The process starts from an existing promising model – the WGSS – which will be further developed, conceptualized into a new model (HSC), piloted, validated, and disseminated for adaptation to new contexts. The project uses a multi-stakeholder and a user-centred approach and aims to reach 200 UA refugee women via 4 HSCs with services adapted to their needs. Over 2,000 stakeholders will be reached in communication and dissemination activities at the local and EU level to promote the scale-up and sustainability of the project. Main deliverables include the HSCs model toolkit, needs and labor market assessments in IT and BG. contextualized Al-skills assessment tool etc.

### **Project summary**

This project aims to implement a strategy in Warsaw, and Arad that adapts and implements a well-developed social inclusion strategy, which has been successfully implemented in Andalucia, Spain for the past six years. This project aims to create a new programme that promotes the integration of Ukrainian refugees in Warsaw, Poland and Arad, Romania.

The Andalusian strategy, known as ERACIS, was launched by the regional government of Andalucia in 2018 and has since been funded by the European Social Fund. Specifically, this will translate into the creation of a new programme consisting of a case manager role, an accessible directory of local services, and a multilingual online tool for skills profiling to help refugees find suitable jobs and navigate local services. The main objective is to foster the social and labour market integration of Ukrainian refugees by using key features of the ERACIS strategy, which has proved to be effective, to address refugees' employability and promote their inclusion in the community.

### **Project summary**

This project responds to key needs of people displaced from Ukraine who found safety in the Baltic states. It targets persistent barriers of establishing an autonomous, stable and rooted existence in Baltic societies, however long individuals will stay. It aims to deploy solutions that have been proven to be effective, but are typically otherwise effort-intensive, and place stress on state structures. It mobilizes the Red Cross network as part of a society-wide effort to invest in individuals. It does so through scalable, innovative solutions that are targeted at specific challenges in labour market integration, language acquisition, local contextual knowledge, and at the same time creates social cohesion opportunities to foster more inclusive societies. It offers solutions that rely on the power of communities and peer support by building connections among participants as well as with local members of the host society. As members of a global humanitarian network, but also embedded societies at a hyperlocal level in a network of branches and volunteers, the Red Cross aims to serve as a channel of entry into society. Goals will be achieved by mobilizing expert knowledge from the private sector (career, language and vocational training providers) as well as from communities. Activities of the project are based on an understanding of existing state services, gaps, and areas of support that states struggle to sustain. The project utilizes in person and digital methods, and actions with a low threshold to initiate and replicable.

The UNITE project aims to contribute to a better integration and social inclusion of refugees fleeing Ukraine by improving conditions for a sustainable labour market inclusion. This project will help to improve status quo in several ways: By transferring good practices of working methods to new countries and contexts, by improving the situation for the individuals that participate in the piloting through the support they are given, and by further developing and evaluating an approach customised for this target group that can be applied by others to improve the situation for Ukrainian refugees. Additionally, by involving relevant stakeholders we assure a growing impact and continuation. By the end of the project, we expect improved working methods, enhanced skills and knowledge among project team members and stakeholders, and more active engagement and participation of Ukrainian refugees in the labour market through targeted interventions.

### **Project summary**

Since the Russian aggression on Ukraine in February 2022, Poland and Germany have accepted nearly 2.2 million Ukrainian refugees, representing the vast majority in Europe. This has led to rapid demographic shifts, causing challenges in integrating these new communities. Currently, there are 350,000 Ukrainian teenagers aged 15–19 in Poland and Germany eligible to work. Lacking local language skills and knowledge of labour regulations, and under pressure to find work quickly, many are vulnerable to exploitation.

The consortium of COZZ, Pro Futuro, Hub of Sustainable Development, UNI Europa proposes an intervention to support these young refugees. The project involves transferring a Ukrainian social innovation – the EduHub multimedia courseware platform – to the Polish and German markets. This platform has already positively impacted 400,000 Ukrainian students and is certified by the Ministry of Education and Science of Ukraine.

We aim to reach 4,000 Ukrainian teenagers in Poland and Germany through the platform and 50 workshops in the 10 largest cities of both countries (30 offline, 20 online). These workshops will enhance awareness of legal, safe, and fair work conditions, provide knowledge about job markets and professional contexts, and highlight available support mechanisms. We will also promote a balanced approach between earning wages and continuing education.

The transfer will include adapting the platform to meet the specific conditions of each labour market, providing tailored support to Ukrainian teens. The project will involve key stakeholders: non-profit organisations (consortium members), social partners (trade unions), academia, public entities (employment offices), and directly the target group – refugee teenagers, their parents, and educators.

By investing in the education and integration of young Ukrainian refugees, Poland and Germany can transform challenges into opportunities for mutual growth and future development.
